## **IN-HOUSE CROP VARIETY EXAMINERS**

WHEAREAS, Republic Act 9168—"Philippine Plant Variety Protection Act of 2002" was enacted on June 7, 2002;

WHEREAS, the main purpose of this Act is to provide protection to new plant varieties and plant breeders;

WHEREAS Title VI Section 28 of Republic Act 9168 provides that *Manner of Conducting Tests. – The Board may carry out the necessary tests, cause the conduct of tests, or consider the results of other tests or trials that have already been done. For this purpose, the Board shall require the applicant to furnish all the necessary information, documents or materials within a period of time prescribed in the regulations.* 

WHEREAS, the Secretary of the Department of Agriculture has issued Special Order 525 Series 2005 creating a pool of crop variety examiners for the Plant Variety Protection Office;

WHEREAS, the present technical staff of the PVP Office Secretariat has been trained extensively on matters relating to Plant Variety Protection,

WHEREAS, the technical staff of the PVPO Secretariat has joined the appointed crop variety examiners of the PVP Office in the conduct of Distinctness, Uniformity, and Stability Tests of varieties applied for Certificate of Plant Variety Protection;

WHEREAS, the Acting Registrar has recommended Dr. Vivencio R. Mamaril, Mesdames Zenaida L. Meneses, and Elvira D. Morales be appointed as In-house crop variety examiners of the Plant Variety Protection Office.

RESOLVED AS IT IS HEREBY RESOLVED TO APPOINT VIVENCIO R. MAMARIL, ZENAIDA L. MENESES, and ELVIRA D. MORALES as In-House Examiners of the Plant Variety Protection Office effective January 2009.
